Release and Wavier of Liability Assumption of Risk and Indemnity Agreement

Good Shepherd Lutheran Church & School Salute to Heroes

IN CONSIDERATION of being permitted to observe, work for, sell and/or distribute goods and/or services or participate in any way in the SALUTE TO HEROES CELEBRATION or being permitted to enter the property of GOOD SHEPHERD LUTHERAN CHURCH & SCHOOL: 26800 NEWPORT RD MENIFEE, CALIFORNIA 92584 for any purpose: EACH OF THE UNDERSIGNED, for him/herself, his/her personal representatives, his/her employees, heirs, and next of kin:

1. Acknowledges, agrees, and represents that he/she has or will immediately upon entering the PROPERTY of GOOD SHEPHERD LUTHERAN CHURCH & SCHOOL: 26800 NEWPORT RD MENIFEE, CALIFORNIA 92584 will continuously thereafter, inspect the area which he/she enters, and he/she further agrees and warrants that, if at any time, he/she feels anything to be unsafe, he/she will immediately advise the officials of such and if necessary will leave the area and/or refuse to participate further in the ARMED FORCES DAY CELEBRATION.

2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the owners and lessees of premises used to conduct the SALUTE TO HEROES CELEBRATION their employees or volunteers, or any subdivision thereof, sponsors, advertisers, promoters, participants, sanctioning organizations, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or SALUTE TO HEROES CELEBRATION and each of them, their directors, officers, agents and employees, all for the purpose herein referred to as "Releasees," FROM ALL LIABILITY TO THE UNDERSIGNED, his/her personal representatives, employees, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE ARMED FORCES DAY CELEBRATION: MAY 16, 2009, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to the SALUTE TO HEROES CELEBRATION, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the SALUTE TO HEROES CELEBRATION whether caused by the NEGLIGENCE OF RELEASEES or otherwise.

5. HEREBY acknowledges that THE VARIOUS ACTIVITIES OF THE SALUTE TO HEROES CELEBRATION MAY BE DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED, also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.

6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the STATE OF CALIFORNIA in which the SALUTE TO HEROES CELEBRATION is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
